**CALL TO ORDER  
AND  
ROLL CALL**

John Harrington called the Statewide Virtual Charter School Board regular meeting to order at 1:00 p.m. and welcomed everyone to the meeting. Ms. Cheadle called the roll and ascertained there was a quorum.

**April 8, 2014 Statewide Virtual Charter School  
Board Regular Meeting Minutes Approved**

**OPENING COMMENTS**

John Harrington said he attended the State Board of Education (SBE) April 24, 2014 regular meeting and today board members will hear the SBEs decisions and an update on the denied application. As Chair of the Board it is important to continue our focus in proving our processes, making it clear on why we do what we do and how we do it. Given the number of changes we have had, I would say we have done a good job with what we had with the cards we were dealt. It is very important that we learn from the recent experience. As we look toward the application process next fall it is important that we take inventory of some of the lessons we have learned to have a clear and transparent process. We want to minimize question marks, confusion, ambiguities for potential applicants. Looking at the growth nationwide of online charter schools it is very likely there will continue to be an increase in Oklahoma in the number of students participating in online charters. It is very important for as a board due our very best to set clear expectations on the front end during the application process and during the actual execution in terms of the accountability that we hold schools to.

## **ADMINISTRATION**

### **Legislative Update**

Sam Duell, Executive Director of School Choice, presented updates and reviewed the failed Senate Bill 573 regarding the SVCSB into a Public School Charter Commission, and Senate Bill 267-provisions for staff support was signed May 1, 2013.

#### **Update on status of appeal by ABLE Charter School of March 11, 2014, decision by the Statewide Virtual Charter School Board to deny application for sponsorship by ABLE Charter School**

Stephanie Moser Goins, Assistant General Counsel, presented an update on the appeal status of ABLE Charter Schools and the April 24, 2014 decision of the SBE. The SBE upheld the SVCSB decision of March 11, 2014. ABLE Charter Schools has indicated their intent to resubmit an application for the next charter school year. They were advised they will be notified when the SVCSB sets deadlines for the next school year.

#### **Proposed Contract for Statewide Virtual Charter School Sponsorship with Oklahoma Connections Academy Approved**

Stephanie Moser Goins presented a recommendation request of a proposed contract for charter school sponsorship from Oklahoma Connections Academy with the Statewide Virtual Charter School Board.

John Harrington concurred with Ms. Goins that a three year contract term is recommended.

Pamela Vreeland made a motion to accept the contract request of Oklahoma Connections Academy. Denise Floyd seconded the motion. The motion carried with the following votes: Mr. Harrington, yes, Mr. Scott, yes; Ms. Vreeland, yes; and Ms. Floyd, yes.

#### **Proposed Contract for Statewide Virtual Charter School Sponsorship with Insight School of Oklahoma Approved**

Stephanie Moser Goins presented a recommendation request of a proposed contract for charter school sponsorship from Insight School of Oklahoma with the Statewide Virtual Charter School Board.

Board Members discussed concerns on lateness of specific final contract documents, and hardware equipment comparisons and offerings.

Denise Floyd made a motion to accept the contract of request of Insight School of Oklahoma. Jarred Scott seconded the motion. The motion carried with the following votes: Mr. Harrington, yes, Mr. Scott, yes; Ms. Vreeland, yes; and Ms. Floyd, yes.

### **Title 777 Emergency Rule Adoption**

Stephanie Moser Goins presented a request for the following emergency rules for adoption:

**OAC 777:10-1-2. Definitions – 70 O.S. § 3-136(F),  
3-145.3, 3-145.4; 75 O.S. § 253 Approved**

Pamela Vreeland made a motion to approve the request for 777:10-1-2 emergency rule adoption. Jaared Scott seconded the motion. The motion carried with the following votes: Mr. Harrington, yes; Mr. Scott, yes; Ms. Vreeland, yes; and Ms. Floyd, yes.

### **FINANCIAL SERVICES**

#### **Administrative requirements for calculation and distribution of state aid to statewide virtual charter schools**

Renée McWaters, Executive Director, State Aid, said the SDE-State Aid section to appropriate state appropriated funds to school districts and charter school. The appropriate funds include the funding formula, school activities and/or line items. Ms. McWaters reviewed school formula and administrative fees; allocations, August 1 enrollment, calculations, average weighted daily membership (ADM); first payment notice prior to August 31, allocation percentages/penalties/adjustments, 11 payments per fiscal year; and data collection/payment process.

Mathangi Shankar, Director, Financial Services, clarified allocation and payment terminology. Allocations are received in August, mid-year allocations in January and payments are made monthly. Federal money for virtual charter schools or any school goes directly to the charter school from the SDE. However, state funds, state aid or any of the state appropriated line items, will go to the receiving entity SVCSB as the sponsor. The SVCSB financial mechanism is currently being set up with the Office of Management Enterprises (OMES).




