7. ADMINISTRATION

a. Introduction of Statewide Virtual Charter School Board Congressional District 4 Representative, Dr. Ethan Lindsey – Chairman John D. Harrington

Mr. Harrington introduced Dr. Ethan Lindsey as a member of the Statewide Virtual Charter School Board. Dr. Lindsey provided the Board with a synopsis of his background.

- b. Presentation and report regarding monthly operations of the Statewide Virtual Charter School Board (SVCSB) office and possible discussion Dr. Rebecca Wilkinson, Executive Director
 - 1. Dr. Wilkinson, Executive Director, provided the Board a review of eight (8) bills considered during the 2017 Legislative Session.
 - 2. Dr. Wilkinson noted SVCSB Research Project will be addressed under item (h) on the agenda.
 - 3. Dr. Wilkinson noted that School Accountability Report Cards are included in the board packet for review.
 - 4. Dr. Wilkinson shared a story from The Oklahoman highlighting a virtual charter school student who attends Thunderbird Academy. She noted that Thunderbird students earned 510 credits during the Fall 2016. In December 2016, five (5) students graduated and 142 cadets are currently enrolled.
- c. Presentation and possible action regarding ABLE Charter School Closure Report

Andy Evans updated the Board regarding the ABLE Charter School closure. A Transition Team for the school has been established consisting of Michael Furlong and ABLE Charter School leadership. The goal is to complete the closure by May 31, 2017. Letters regarding school closure have been mailed to parents/students with "Return Receipt Requested" and e-mails have been sent with a "Read Receipt." Mr. Evans reported the ABLE governing board recognizes their responsibility regarding financial and student records. There were no questions from the Board, and no action was taken on this agenda item.

d. Presentation and possible discussion regarding the Oklahoma Educational Quality and Accountability (OEQA) School Performance Report Preliminary Issues for Oklahoma Virtual Charter Academy (OVCA)

Dr. Wilkinson shared the Preliminary Issues Report for Oklahoma Virtual Charter Academy (OVCA). Dr. Wilkinson answered questions from the board and noted that the Preliminary Issues Report is phase one of the school performance report process.
