- a. Presentation and report regarding monthly operations of the Statewide Virtual Charter School Board (SVCSB) office and possible discussion
 - Dr. Wilkinson provided an update on board membership. She noted Labor Commissioner Melissa McLawhorn Houston has been appointed as Secretary of Education and Workforce Development and now an Exofficio member of the Board.

- 3. Dr. Wilkinson provided the Board with an update regarding the new electronic meeting program, BoardBook. She noted Ms. Stickney is working in BoardBook and will provide training to the Board during the September and October meetings. BoardBook information is available to Board members wishing to preview.
- 4. Dr. Wilkinson updated the Board on 2018 Legislative Bills and Administrative Rules. The Administrative Rules were approved by Governor Fallin. 2018 legislation was reviewed and interim studies relating to virtual charter schools announced.

- 5. Dr. Wilkinson provided the Board with an update regarding school compliance. Recent compliance focus has been the review of academic student records.
- 6. Dr. Wilkinson recently attended a Public School Options event where she was able to visit with virtual charter school students and families.
 - Dr. Wilkinson visited with a military family. There is a significant group of mobile families at Tinker Air Force Base who are enrolled in K-12 because it is nationwide, and are able to keep their children's education consistent. The families have developed a cohort to support each other and their children's education.
 - She also visited with parents who have homeschooled their children, but now take advantage of the option a virtual charter school to provide a more stable curriculum for their children.
 - Lastly, Dr. Wilkinson visited with three (3) high-school students and discussed the benefits and challenges of virtual charter school education. Their answers mirrored the recent research study performed in that the benefit is flexibility and time. The challenge is work ethic, knowing you have to stay focused and not procrastinating.

b. Presentation and possible discussion regarding eSchool Virtual Charter Academy Application for Initial Authorization

Mr. Seth Robbins, Compliance and Finance Officer for eSchool Virtual Charter Academy and Mr. Eddie Lynn, President of eSchool Virtual Charter Academy Board, presented a summary report of eSchool Virtual Charter Application for Initial Authorization to the Board in support of authorization.
